



# Rules

FOR EVERYONE'S SAFETY AND PLEASURE, WE ASK FOR YOUR ASSISTANCE IN OBSERVING THESE POLICIES AND RULES DURING YOUR VISIT:

## 1. Reservations, Registration & Visitors

- Campsite rates include 2 adults and up to 4 children under the age of 18. Cabin rates include 2 adults and 2 children. Maximum occupancy is 6 people per campsite and 4 people per cabin.
- Please check-in/register/pay your balance in the office or online before proceeding to your campsite. Do not change sites unless cleared and confirmed by the office first.
- Check-out time is 11:00 a.m. Check-in time is 1pm for cabins and campsites, 3pm for rental trailers and cottages. If you have a rental unit you will be asked for a credit card to be imprinted for a key/damage deposit on check in. On departure this will be shredded after the key is returned and the unit has been checked. If you depart late, or if the unit has been damaged, you may be subject to the loss of your deposit and additional fees if the damage exceeds the deposit. Special arrangements must be made if you wish to arrive or depart from a rental unit outside of office hours.
- Visitors and overnight guests must check in with the guard at the gate or the office before entering the campground and pay applicable fees. Visitors staying less than 4 hours are charged \$2 per person; those staying more than 4 hours are asked to register as day using guests, adults \$6, children \$3. Visitors are required to leave the campground prior to 8pm. Those wishing to stay after 8pm must register in the office as overnight guests, numbers permitting.
- A 2-night minimum stay is required for future reservations and a 3-night minimum stay on some event or holiday weekends.
- Reservations are guaranteed for a site type, not a specific site, although we will do our best to honor your requests. Requests for a specific site may not be honored for reservations of less than 5 nights. If you wish to extend your stay, you may remain on the same site only if the site is not already reserved. You

will have to move by check out time on the day the next camper's reservation begins.

- The maximum stay is 21 days for tent camping and rental units, and 90 days for camping with other types of units. If you would like to stay longer, please see the office manager.
- A deposit payment of the full amount up to \$300 is required on all reservations at the time they are made. Also, on reservations for rental units full payment must be made at least 2 weeks in advance of arrival. We request that all campsites be paid in full 2 days or more prior to arrival to facilitate the check-in process. Reservations without deposits will be not be held.
- Campsite reservations cancelled or changed with at least 7 days notice in advance of arrival will incur a \$20 charge per week cancelled or changed. Campsite reservations cancelled or changed within 7 days of arrival will forfeit a one night deposit per week cancelled or changed. Rental unit reservations cancelled or changed with at least a 2-week notice will forfeit a one-night deposit per week cancelled. Rental unit reservations cancelled or changed within 2 weeks of arrival will forfeit the full payment unless the unit is re-rented. All refunds will be made in the same form as the payments received.
- If you need to leave your campsite earlier than anticipated and you notify the office by 11am at least one day before early departure, fees for unused days will be returned less a \$20.00 early departure fee provided the minimum stay requirement has been met. Refunds or credit for rental units is dependent on if the unit is re-rented.
- Sites and rentals will not be rented to persons under 21 years of age or to groups with unrelated persons under the age of 21.

## 2. Vehicles, RVs, Boats & Restricted Areas

- Please observe all posted signs & do not enter areas marked "authorized personnel only".
- Speed limit: 10 mph (15km/h).
- All vehicles must display a vehicle pass at all times. Rates include one vehicle per site; additional vehicles are \$5 per night. A maximum of 2 cars may

be parked on a site or 1 car at a cabin. All other vehicles can be left in our overflow parking lot by the guard shack (extra vehicle fee will apply).

- ATVs, motorized scooters, mini bikes, go carts and gas-powered carts are prohibited. Off-road use of vehicles is also prohibited. If you are mobility challenged and require the use of a prohibited vehicle, please contact the office manager. All motorized vehicles must be operated safely and by a licensed, adult and insured driver.
- Bicycles, roller blades and skateboards are not permitted indoors, on the mini-golf or in the pool areas.
- Boats and cargo trailers are not allowed at sites. They must be parked in the overflow lot. Please obtain a parking pass from the office when you check in. Additional fees may apply depending on the season and duration of stay.

- If you wish to wash your vehicle or RV at your site, please do so without the use of water.

- Discharge onto the surface of the ground of such liquids as sink and shower wastes is prohibited by law. Campers must use one of our dump stations to empty any liquid waste.

## 3. Fireworks, firearms or any type of explosives are strictly prohibited.

## 4. Alcoholic beverages may be legally kept and consumed on your site. Alcoholic beverages are not permitted at our swimming pools.

**5. Pets are allowed on campsites** as long as they are quiet, supervised and leashed at all times. Pets are only permitted in or around specific cabins. When reserving a cabin you must state if you will be bringing a pet. Pets are not allowed in our rental trailers, cottages, bathhouses, stores, or swimming pool areas. Pets must be picked up after and not left unattended outdoors at any time. Barking dogs and other problem pets will be asked to leave the property.

## 6. Quiet hours are 11 p.m. to 7 a.m. Please be considerate of your fellow campers at all times and keep the volume down.

**7. Respect Others' property.** Do not cause damage to property such as structures, trees, bushes, or light fixtures. Thieves and vandals may be prosecuted, and they and their families

will be asked to leave the property without refund.

**8. Keep a watchful eye.** To avoid petty theft, keep your vehicles locked and tempting belongings secured. Campers are asked to police their campsites and restrooms, help maintain clean grounds, and to always leave their campsites in good order for the next occupant. Please report suspicious behavior to the office or guard house.

**9. Pools open during the summer season** begin to open at 9am and close by 10pm. Our heated pool (open winter months) opens at 9am and closes by 5pm depending on office hours. Pools are for registered guests only. Children under 14 years must be supervised by an adult.

**10. Parents are responsible for the actions and safety of their children.** All campers under 18 years of age must return to their campsite for the night by 11pm. For your children's safety, parents are asked to accompany their children in the comfort stations.

**11. Comfort stations must be closed several times daily for cleaning.** Check your map to locate and use the next closest comfort station while that nearest you is being cleaned.

**12. Trash should be bagged and placed beside your site post for pickup.** Do not leave trash outside overnight due to squirrels and raccoons.

**13. Campfires are allowed at your campsite** and can be built directly on the ground. Firewood is sold at the grocery store. If you chop down a tree or branch, realize it won't burn as it is green and we are entitled to collect twice the value of that tree.

**14. We reserve the right to provide a safe and enjoyable environment for all.**

**Campers must agree to abide by these rules as well as any instructions from our staff.** Campers not complying may be asked to leave immediately, and if necessary, prosecuted by law. Please report any violations to the office.

**Holiday Trav-L-Park will not assume responsibility for lost or stolen articles. Please keep your vehicles locked and property secured.**
